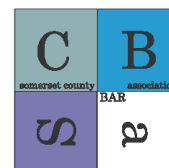

- **Application Deadline:** February 10, 2012 at 3:30 pm (**Must be at SCBA Office by the deadline date and time. Only fully completed applications will be accepted.**)
- **Fee:** \$200 payable to the “**Supreme Court of the United States**”. Payment must accompany the application.
- A **Certificate of Good Standing** must accompany your application (this must come from the NJ State Supreme Court and may take up to 4 weeks for processing, so plan accordingly)
- Your application must have **two sponsor signatures**.
- Applicant is allowed to bring **one guest** (6+ years of age) **to the ceremony**.
